TRAP:

- Poker run the Montrose stop was not easy for the boaters. Next year consider another location for a stop. Profit of \$3,290 with 187 players/32 boats. Made \$1,100 on basket. The 50/50 in the amount of \$200 was donated back to the First Mates.
- Steak fry was great in July.
- Have sold 110 anniversary shirts to date.
- Leslie Malinski was on 'She Rock' promoting the Club good advertisement.
- Having Richie Lee after the Lake Cooper poker run on the 26th. This band should draw a good crowd question was asked if members should dress '50's style?
- The upcoming August steak fry the Meyers will be out of town at grandson's wedding Hendrickson's are heading this event.

SOCIAL: Gail Meyers discussed the following with the Board:

- The Abate poker run is coming up this Saturday, July 20. Need to give Gail a \$75 membership gift certificate for a gift. Parking for motorcycles, will tape area off at 9 am. Bikes will be here mainly from 3:30 4:30 pm. The ride originates in Ft. Madison. Jeff Z. and Gary P. will help tape off. Dave G. can borrow orange cones from the school.
- Christy Lucido has a link to post pictures on our website.
- Will have a food truck in August.
- Southern Rail Band that will be at the steak fry in September suggested we charge a cover charge as they have a following of 50-60 people, but their fee is only \$900. This suggestion was voted down as we have a \$2,000 set limit for charging cover.

BAR SALES: Gary reported the following in bar sales:

- At the Commodore's discretion, Dick Meyers is removing Dave Grogan and Kathy Dinger from the Bar Committee.
- Gary Platz reported that last month beer sales were off slightly resulting in \$2,400 less sales. Liquor sales were up \$500. Wine was steady, soda sales were down some. Liquor purchases were up, mainly due to large parties and an extra delivery. Liquor and slushy sales are very profitable. All in all bar is holding its own, we had a good June even though beer sales are down 16% YTD.

BUILDING & GROUNDS: Jeff /Rusty reported on the following:

- Floatation device is ready for pickup.
- The upriver boat lift cable broke Thursday morning. New cable has been installed with Newberry's help. We need to order more replacement cable, approximately \$275 per Jeff.
- The outside ice chest has an outlet that keeps kicking out. Jeff blew out and washed the coils, then gave the chest some shade. Jeff Z. and Rusty G. are working on the ice chest.
- The gas tank was inspected need new sticker for both side of the tank noting 87 octane. The new hose is here. Need to replace the nozzle will ask Johnathan H. to help.
- New solar lights have been added to the handrails of the Gas and Courtesy docks.
- Cat 6 cabling has been installed between the switch above the bar and the board room. Needs to be tested and put into service.

BOAT STORAGE: Jeff/Sara reported the following to the Board:

 would cost \$78 to place a judgement on his boat, the sheriff would serve the papers,
